ALASKA[®]FORT is an easy application it is water soluble fertilizer. A single product can be used without mixing with any other fertilizers to achieve the same result. Can be used in all fertigation systems: drip, sprinklers, central pivot and surface irrigation systems and for all crops.

Application Rate:

1. Vegetables:

Open field : 0.75g - 1.5g/plant/day.
 Protected : 1.5- 5.5kg/500m²/appl.

2. Fruit Trees:

100g/tree/week or 1-5 kg/season
 Center pivot : 6-8Kg/ha/appl.
 Foliar : 2-3Kg/ha/appl.



Note: **ALASKA[®]FORT** can be mixed with all water soluble fertilizers, except the calcium based.
